Process For Collecting Annual Licence Fees



Background

- (1)** All CMA individual licences have the following **Special/Additional Licence Condition:**

“The licensee shall be subject to the applicable annual license fee which is equivalent to 0.5% of gross turnover less the applicable rebates, provided that the applicable annual license fee shall not be less than 0.15% of the gross turnover of the preceding financial year of the licensee or RM50,000.00, whichever is greater”.



Background - Continue

(2) Reg. 33(3) of Licensing Regulations 2000:

- On 1st anniversary of license and annually thereafter, licensee to pay a sum of RM50,000.00 as initial payment of the applicable annual license fee; and
- Balance due, if any, within the time period stated in the notice sent by MCMC.



Background - Continue

(3) Reg. 33A of Licensing Regulations 2000:

“Calculation of the applicable annual licence fee

33A. For the purpose of calculating the applicable annual licence fee payable under subregulation 33(3), each individual licensee submit its audited accounts to the Commission within three months from the end of its financial year”



Annual Licence Fee Collection Process (Updated)

Phase 1	Payment of initial sum of RM50,000.00 per licence upon licence anniversary date
Phase 2	Submission of Audited Accounts within 3 months from FYE (Calculation of Max. 0.5% & Min. 0.15% of GAT) Notification of annual fees payable if charged with max. rate of 0.5%, the rebates entitlement will also be mentioned. Balance fee due as set out in the notice must be settled in full
Phase 3	Application for rebates (within 1 month from receipt of Phase 2 Notification from MCMC) Approved rebates entitlement will be refunded (if any) upon completion of processing



Payment of Annual Licence Fees

- !** MCMC will NOT issue any notification letter requesting payment for Phase 1 - initial payment.
- !** For non payment of fees within the timelines given, MCMC will take the necessary regulatory action as set out under the CMA 98.

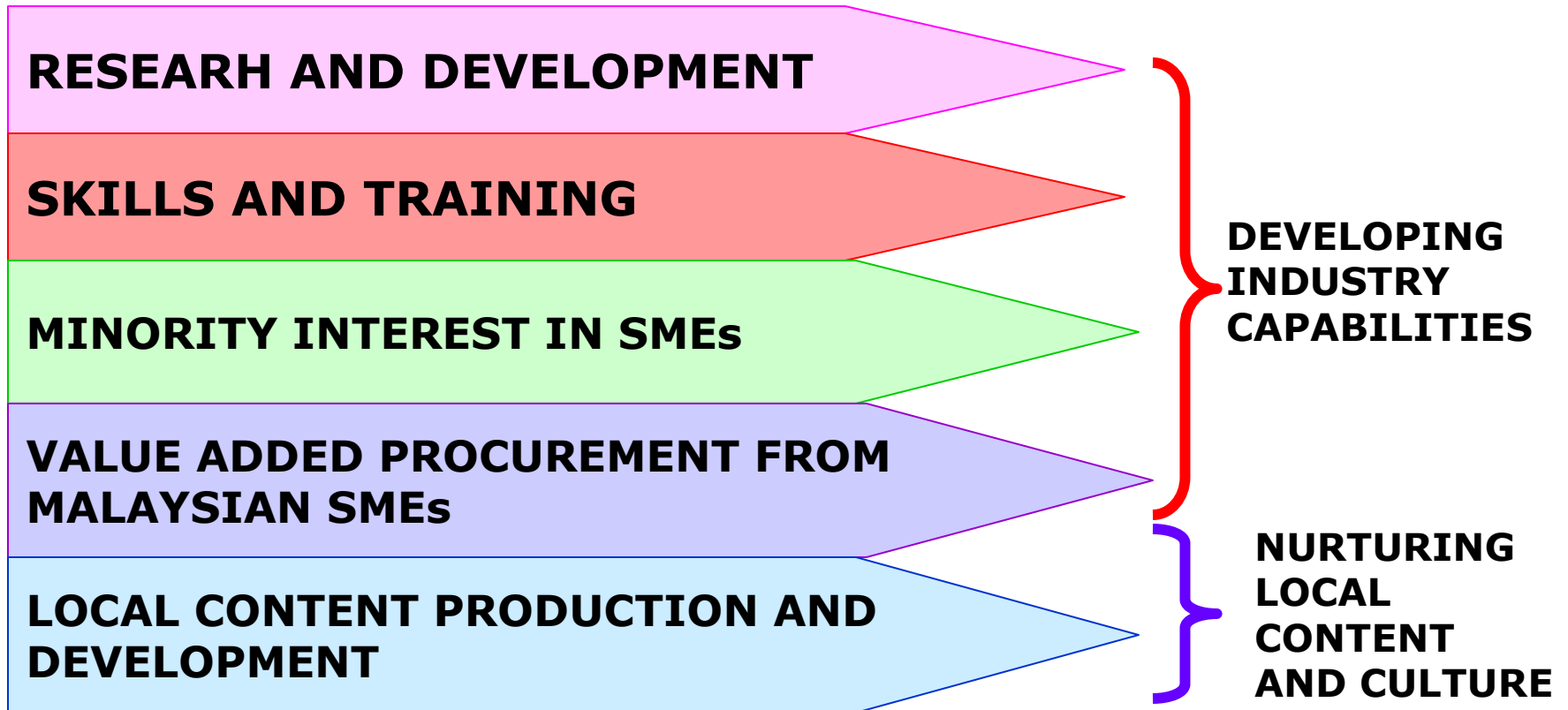

Who Is Eligible for Rebates?

- ✓ ONLY for CMA individual licensees who are charged with Max. rate (0.5% of GAT) of Applicable Annual Licence Fee
- ✓ Must first have received Notification letter from MCMC (Phase 2 of process)
- ✓ Licensees have incurred industry development expenditure under the 5 categories. *Refer link:*
