2	We would like to inquiry what is the requirement of the site layout. We understood that the endorsed drawing by professional engineer is after the LOI received. Thus, we would like to inquiries the details of the site layout during tendering process. Is it just standard drawing similar to appendix 2, Technical Part Specification, 2. General Site work, 2.2 compound layout page 6 of 27?	The respective sites' tower height and subsequently the site layout has been predetermined. As such, for the purpose of the proposal, the tenderer can use the standard site design provided in the Technical Specifications.  Tenderers have the option to conduct site survey and submit site layout based on actual site condition. The tenderer to decide which method is preferred.
3	It is mentioned in Appendix 3 battery backup supply should be 8 hours but in BOQ only mentioned 6 hours. Which one should prevail?	The BOQ.
4	What is the "Deposit Perobohan" stated in the BoQ of Part 1? Can you give some example?	Certain PBTs impose "deposit perobohan". The tenderer shall find out which PBT, the sum of the fee and quote it accordingly in the BoQ.

5	The Site ID was wrongly written as U1S037 in the BoQ of Part 1 for the site name, Jalan Kota Belud-Kudat_3 in Cluster 11, Sabah. Please advise.	Yes, there is an error in the Site ID in the BoQ for Part 1, Cluster 11 for the Site "Jalan Kota Belud-Kudat_3". The correct site ID for "Jalan Kota Belud-Kudat_3" is "U1S036" as stated in the Appendix 1 of the RFP, the title of the Excel worksheet itself and as stated in the BoQ for Part 2, Cluster 11.  The Tenderer to correct this detail during submission.
6	How many set of one-off document should we submit to MCMC if we submit (4) four clusters for Part 1 only?	One document per tenderer.
7	Site Layout was written in the 7.2 (a), Section B as one of the item we need to write in the Technical Proposal of Part 1. May I know which types of Site Layout are you expecting from us?
