MINISTERIAL DETERMINATION ON NOMINATED FACILITIES PROVIDER

DETERMINATION NO. 12 OF 2024

IN exercise of the powers conferred by sections 10 and 130 of the Communications and Multimedia Act 1998 [Act 588], the Minister makes the following determination:

Citation and commencement

1. This determination may be cited as the **Ministerial Determination on Nominated Facilities Provider**, Determination No. 12 of 2024.
2. This Determination shall come into operation on the date of its registration.

Interpretation

3. For the purpose of this Determination, unless the context otherwise requires:

"Agreement" means the Nominated Facilities Provider appointment Agreement between N.U.R Distribution Sdn. Bhd. (199601035453) and N.U.R Power Sdn. Bhd. (200801006376) dated 1 June 2021; and

"network facilities" mean the optical fiber cables and towers, poles, ducts and pits used in conjunction with other network facilities owned by N.U.R Distribution Sdn. Bhd.

4. Any term used in this Determination shall, unless expressly defined or if the context otherwise requires, have the same meaning as that contained in the Act or the Regulations made under it.

The network facilities subject to nomination

5. Pursuant to the Agreement, N.U.R Distribution Sdn Bhd has allowed N.U.R Power Sdn. Bhd. the right to access and use of the network facilities.

6. These network facilities fall under the category of fixed links and cables and towers, poles, ducts and pits used in conjunction with other network facilities under the Communications and Multimedia (Licensing) Regulations 2000 [P.U.(A) 129/2000].

7. The location of the network facilities is specified in **Schedule 1**.

8. N.U.R Power Sdn. Bhd. shall notify the Commission in writing not less than sixty (60) days on any changes to the network facilities subject to nomination, location of the network facilities or the extension of the duration of the Agreement before such changes or extension takes effect.

The Nominated Facilities Provider for the purposes of this Act

9. N.U.R Power Sdn. Bhd., a Network Facilities Provider Individual licensee No. NFP/I/2000/482 shall be the nominated facilities provider for the network facilities for the purposes of the Act.

SCHEDULE 1

LOCATION OF THE NETWORK FACILITIES

NUR Power is the Power Utility in Kulim-High Tech Park ("KHTP"). Being an independent power utility in KHTP, NUR Power owns the following main substations, via its subsidiary known as NUR Distribution Sdn Bhd ("NUR Distribution"). The main substations in KHTP are:-

1. Pencawang Masuk Utama (PMU)
2. West Substation
3. East Substation
4. South Substation

These network facilities are owned by NUR Distribution, and it will be accessed or used by NUR Power.

The fibre optics link between the main substations, and the connection between the main substation with all key industrial companies in KHTP, are as follows: -
